Conference "Issues in Contemporary Church Legislature"

FOREWORD TO THE CONFERENCE

The modern era, through its fundamental changes, has confronted the Orthodox Church with serious ethical, political and juridical issues and challenges. Amongst these, one of the most pertinent is the problem of contemporary Church Legislature. There is no doubt that the institutional (legislative, canonical, constitutional) dimension of the Church represents the *sacred* reality par excellence of the liturgical being of the Church. It is thus that the theandric "taxis" and salutary "oikonomia" are vouchsafed and protected. However, in the practices of the local Churches this reality is significantly neglected. Nevertheless, we do believe that all of the sanctified canons, composed by the blessed Fathers and bestowed upon the Church, serve to beautify the Church and to ground its order in good nature, according to the apostolic traditions of the divine Gospel teaching.

Commission for the reform of the Constitution of the Serbian Orthodox Church, appointed by the Holy Synod / Council of Bishops of the Serbian Orthodox Church, approaches the forthcoming constitutional reform by working towards a Constitution which would find itself commensurate to the authentic canonical tradition of the Church. Taking this as its clear goal, our local Church is determined to commence the necessary preparations for a new Constitution. It goes without saying that one of the necessary steps in the direction of realizing such a goal is given by theological dialogue thematizing the essential elements which under grid Church-canonical law itself. The current Constitution of the Serbian Orthodox Church has been accepted by the Holy Synod / Council of Bishops in 1931. This Constitution appeared after the establishment of the Kingdom of Serbs, Croats and Slovenes, and after the reestablishment of the Patriarchate of Peć. Following the line of subsequent events, the Constitution was adapted to the new circumstances after the Second World War. Moreover, after 1947 the Constitution underwent yet another series of changes, although of minor magnitude. Despite the best of intentions this Constitution bears the burden of its own time (e.g. the rise of nation-states, appearance of autocephalous Churches). This is why it has not shown itself thoroughly capable to withstand a profound theological-ecclesiological critique: especially in light of the newly emerging historical circumstances.

The new circumstances within which our Church has found itself place before us an essential need for constitutional reform. The reform can not be directed only towards simple changes in particular articles of the Constitution since it requires a more profound level of analysis. It is at this, more profound, level that the Commission is to investigate the adequacy of the current Constitution in relation to the canonical tradition of the Church: in relation to the self–understanding of the whole Catholic Orthodox Church.

All the above mentioned problems instigate our local Church to organize and assemble an international academic conference entitled: Issues in Contemporary Church Legislature.

By virtue of participation promised by the most eminent Orthodox theologians this Conference is to serve the needs of our local Church. However, it may prove important for a wider and more common insight into the problematic of modern Church legislature in the Orthodox Church in general, as well as for an understanding of its commensurability with the catholic canonical tradition of the Church. At this moment we find ourselves at a "crossroads" wherefrom one might see how our local Church should enrich its ecclesial–canonical experience and knowledge by means

of the good service of others. In other words, our Church does wish neither to act nor to theorize in isolation from others. Therefore, neither should the question of Church legislature be thematized and resolved separately, without consultation with the Orthodox from other local Churches. The forthcoming Conference is to tackle the following problems:

- a) The question of concordance of contemporary Church law and legislature in relation to the canonical tradition of the Church;
- b) The question of the relationship between the synod / council of bishops and any individual bishop (where this body, i.e. synod / council, must not be viewed as a body over imposed to the given bishop);
- c) The question of determining problematical aspects of autocephaly;
- d) The question of ascertaining the foundations for the canonical functioning of the Church in contemporary circumstances in any given state;
- e) The question of the relationship between the Church and the State in the European Union (e.g. the new state of affairs in the local Orthodox Churches);
- f) The question of Diaspora (e.g. problems relating to the legal prerogatives of the mother Church within the framework of the existing legislature of another state which considers the Church communities to be mere "congregations");
- g) The question of canonical and linguistic reformulations which are to serve our contemporaries as more adequate means of defining the basic concept of the Church.
